Missouri American Water Rate Case 2016 – Updated Chart

CSC & Employee Facts

- Missouri American Water learned of the final rate order by the Missouri Public Service Commission (PSC) on June 25, 2016. The case was filed on July 31, 2015.
- New water rates went into effect on July 20, 2016.
- New sewer rates went into effect on July 22, 2016.
- Because this change in rates takes place during the middle of a billing cycle, customers will see two different rates for the fixed charge, and two different rates for the volumetric charge. These will appear as separate line items on the invoice.
- Rates for all classifications have changed including private fire service. New tariffs are on the web.
- The dates prior to July 20 and 22 show one rate for fixed and volumetric charges, while the dates of July 20 and 22 show the new rates for fixed and volumetric charges.
- From January 2012 to January 2016, Missouri American Water invested approximately \$442 million in water and sewer infrastructure statewide.
- These investments in water and sewer systems were the main driver in this rate case. The improvements allow us to ensure reliable service and broader goals of health, safety and economic development.
- The PSC consolidated rates in Missouri by region, as outlined below. Consolidation allows for economies of scale, which reduces the cost most rate-payers face.

Water:

- Zone 1 East Central: St. Louis Metro, Mexico and Jefferson City
- Zone 2 Northwest: Platte County, St. Joseph and Brunswick
- Zone 3 Southwest: Joplin, Warrensburg, Spring Valley, Lakewood Manor, Ozark Mountain, Lake Taneycomo, Maplewood, Riverside Estates, Stonebridge, Saddlebrooke, Emerald Point, Rankin Acres, Whitebranch & Tri-States

Sewer:

- District 1 All Wastewater Systems except Arnold and Rock Creek
- District 2 Arnold and Rock Creek
- A low-income assistance program was approved as part of the rate case. Missouri American Water will
 work with interested parties to determine a service territory to implement a pilot program to benefit
 customers who struggle to pay their water bill.
