



Schedule of Rates – Pontiac District

In accordance with Illinois Commerce Commission regulations, the following rates for water service have been in effect since June 16, 2017.

General Water Service

The rate for metered water service consists of a facilities charge, varying with the size of meter, a use charge, a state recovery charge and a fire protection service charge.

Gross Receipts Tax

A gross receipts charge will be applied to all facilities charges, use charges and public fire protection service charges at the rate of 0.1%.

Illinois CC Assessment

A fixed charge to recover amounts assessed by the Illinois Commerce Commission for its funding at the rate of \$0.01 per invoice.

Private Fire Protection Service Charges

Available for private fire protection service. The rates shall consist of a monthly charge based upon the size of each fire service connection, and the number of company owned hydrants attached to the service, as follows:

A monthly charge of \$50.15 per hydrant is payable for each company-owned hydrant on a fire service connection. There is no additional charge for customer-owned hydrants or for sprinkler systems.

Standby Demand

\$0.1408 per 100 gallons per day of subscribed daily standby capacity
\$0.3495 per 100 gallons for first 748,000 gallons used in any month
\$0.1980 per 100 gallons for all usage in excess of 748,000 gallons in any month
\$0.6280 per 100 gallons for all 100 gallons in excess of subscribed daily standby capacity
\$0.4000 per 100 gallons for all supplemental 100 gallons in excess of subscribed daily capacity
